

- 7. Describe how and when 1st response alerts or Public Service Announcements to registered members via Email. As alerts are made available from any marine disaster an email will be sent to members with a description of event, any immediate danger to coastal constituents, facilities, contact numbers for command structure and other 1st response agencies. - 8. GIS dashboard will be available for visual purposes as soon as updates can be made. From a smart phone our users will be able to mouse over his or her location and see what conditions are associated with the event. Conditions like weather and radar, ocean currents, wind currents and possibly aerial imagery of the event. Steve Jones (5 minutes)
- 9. A virtual library based on location with be available for viewing any documentation related to the current location.
